### City of Hemet Non-Profit Business License - 501 (c) 3 required

The city of Hemet does not charge a business license fee for any organization that qualifies for nonprofit status. Instead, all qualifying nonprofit organizations will receive a City of Hemet Non-Profit Business License. There is no City of Hemet fee; however State of California SB 1186 \$4.00 fee does apply.

In order to obtain a Non-Profit Business License, complete a City of Hemet Non-Profit Business License application and return it with a copy of your IRS 501 (c) 3 letter and payment of \$4.00. Once received and verified, your organization will be issued a City of Hemet Non-Profit Business License.

Please note: The issuance of a City of Hemet Non-Profit Business License shall not entitle the holder thereof to carry on any business unless he/she has complied with all the requirements of the Hemet Municipal Code and all other applicable laws, nor carry on any business in a building or on any premises situated in a zone or locality in which the conduct of such business is a violation of any law.
